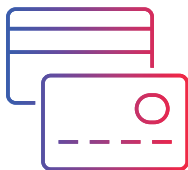

It was added in the US first and will be rolled out globally. The solution effectively accepts customer account information, replaces it with a token and feeds the token to the SAP system.
